On 10th July 2021 RGPC achieved another historic Safety milestone by achieving **18 Million man-hours without a single Lost Time Incident (LTI)** and set a new benchmark for Safety performance in the region for a fully operating plant.



RGPC event triangle provides a comparison of the health and safety performance of current year versus previous year. Below event triangle is the comparison made between 2020 and 2021.




Cumulative Man-Hours- 18,881,339 Hrs. Without LTI


MAN HOURS & MANPOWER






Below incident graph summarises the incidents reported in the year 2021.


INCIDENT - GRAPH











UNSAFE ACT/CONDITION REPORTED






FRESH EYE OBSERVATIONS






SAFETY WALKTHROUGH REPORTS (SWR)



HIGHLIGHTS FROM HSE ACTIVITIES

Health and Working Environment


- Developed and implemented CoVID-19 health and safety plan.
- Developed and updated risk assessment on fatigue and driving safety.
- Regular Noise survey was done and control measures were put in place.
- Temperature and humidity survey were done during summer months and effective control measures provided and RLIC regulations were followed.
- Continuous housekeeping was enforced for a clean site.

Safety and Security

- E-gate system implemented in the security gates and buildings.
- Continuous effort was made to give 100% safety coverage to all working area.
- Surprise checks were done at the gates to ensure only authorized men and safe equipment are let in to the plant.
- Log In/Out for entry and Exit, restricted to ID holders.

Safety and technical integrity

- Replaced all jubilee clips used on hoses, crimped hoses are used
- Covered platforms and walkways With plywood sheets and green nets.
- Complete overhead protection using scaffold platform.
- Safety nets were provided on all static scaffolds
- Fire blankets and fire-retardant sheets were spread on the scaffold platforms in cooling tower cell to plug all gaps to ensure100% fire safety.
- Many HSE alerts /incidents/accidents were discussed in the tool box meeting. It is also displayed on the HSE boards...
- Multi lingual signage and posters were used in the site.
- Daily site inspections with the client/contractor HSE representatives were done.
- Increased follow up with contractor companies to improve safety.
- Worker and safety officers ratio 25: 1
- HSE Bulletin board at the site.



HEALTH & WELFARE

RGPC plan welfare for employees in advance of work starting and make sure that workers have sufficient drinking water, toilets, washing facilities etc.

- Regular noise survey was done and control measures were put in place.
- Drinking water is provided on daily basis in each work locations.
- For EPC adequate toilets and washing facilities are provided. Facilities are well lit and ventilated.
- Temporary Rest room and Prayer rooms with appropriate facilities are provided.

Heat Stress

One of the main occupational health hazards we face in Qatar is the hot summer. During the summer months temperature rises above 50 degree Centigrade during the day. During the year, RGPC has implemented a rigorous monitoring programme in parallel with the Company Heat Stress Management System.

A heat stress campaign was carried out comprising special trainings about the heat stress, issuing heat index cards to one and all, different coloured flags indicating different level of heat index displayed around the site.

During the year, RGPC has successfully achieved the goal of Zero Heat stress related incident cases. The following measures were implemented during the summer months to prevent heat stress related risks and illness;







- Air-conditioned rest shelter and air-cooled confined space including sufficient number of ventilations.
- Cooling water and water dispenser at various areas of the plant.
- Individual water bottles.
- Training to all individuals.
- Hydro-meter used for monitoring the temperature and humidity measurement on continuous basis.
- Heavy works planned for cooler part of the day and rest intervals increased.
- Flag system meticulously followed.
- Cooling Jackets for all staff.







COVID-19 RESPONSE

Overview

The COVID-19 pandemic presented an unprecedented challenge for RGPC. RGPC was quick to take all necessary precautions for workers in line with the COVID-19 infection prevention and control guidelines.

Throughout the pandemic we implemented a robust strategy to control the spread of COVID-19, our top priority has been to minimise the risk of infection among our workers and to ensure their safety. The RGPC remained in constant



dialogue with workers, contractors and the relevant authorities

Monitoring the implementation of COVID-19 preventative measures.

COVID-19 inspections were carried out daily across RGPC workplace to ensure hygiene and disinfection of area, social distancing in mess hall, toilets and buses, compliance in wearing masks, temperature readings and PPE checks at security entrances.

- Tracking of action points will be included in the MOM and delegated to concerned person who can act on the issue and so resolve it within a reasonable timeframe. Where an action point keeps reappearing in successive meetings it helps identify items which need to be resolved immediately and may highlight potential underlying problems with the existing H&S procedures in place.





RGPC OHS PLAN FOR 2022

RGPC aims to progress the activities identified within this report and will develop further priorities based on the findings of health and safety audits, consultation with the workforce and changes to law and industry standards. In addition to achieving our performance targets in 2021 we aim to implement the following actions;

- Management of CoVID- 19 health risks
- Continue monitoring the Contractors working areas to ensure the OHS compliance.
- Increase the frequency of management plant tours.
- Safe completion of major outages.
- Safety observations close-out rate > 95%.
- Occupational Health- Management of occupational health risks and to prevent occupational illness
 - CoVID-19 PCR testing for staff, contractors
 - o CoVID 19 Vaccination plan for staff and contractors
 - o Noise Survey
 - o Legionella test
 - Heat Stress Prevention
 - Occupational Health and Safety Meetings: OH &S Management Review Meeting / Monthly RGPC Safety Representative meeting / Contractor Safety Meeting
- Internal and External trainings to increase competency and awareness.
 - Health and Safety Audits: Internal and external OHS audits and Permit to Work field audits
 - Emergency Mock Drills: Mutual Aid drills between Ras Girtas Power Company & RLIC / Internal Emergency Drill- for both day shift and night shifts including for the contractors.
 - RoSPA Award- 2022

HEALTH AND SAFETY INITIATIVES/IMPROVEMENTS FOR 2021-25

- **IOSH Safety Training** IOSH training is focused for all staff and management and the course will be started from the 3rd quarter of the 2021.
- Installation of H2S gas detectors around the fence- Due to the close proximity of the Dolphin Energy beach landing valve station at the west side of the plant, H2S detectors will be installed along the RGPC boundary. These will trigger alarms and activate the plant siren to alert personnel working at site to approach the safe locations established.
- External Trainings for crane operators, forklift operators and riggers- third party certification training for lifting equipment operators shall be conducted by the first quarter of 2021.
- Safety Awards: We will continue our great success in achieving the renowned RoSPA health and safety awards by participating in the completion. The award submission will start from January 2022.

- Implementation of in-house Safety Awards: Safety award scheme for staff and contractors will implement for the upcoming major shutdown activities.
- Improvement on Safety Signages: Plant survey and associated works to improve the safety signage requirement will start form 2nd Quarter of 2021.
- **Additional Car Parking facility**: Due to the increased activities and presence of contractors, addition parking facilities will be provided outside the Plant at north side.
- Implementation and integration of e- HSE module in SAP: HSE module will be developed for HSE incident reporting and investigation, reporting safety observations and safety walkthrough points and follow up. The system will be ready for use by 4th quarter of 2021.
